OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The Tribune Publishing College Fair Sweepstakes (the "Promotion") starts at 12:01 a.m. ET on February 1, 2021 and ends at 11:59 p.m. ET on March 20, 2021 ("Promotion Period"). The sponsor of this Promotion is Tribune Publishing Company ("Sponsor"). The Promotion is subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor. Sponsor's designated clock is the official timekeeping device of the Promotion.

- 1. Eligibility:** This Promotion is open to legal U.S. residents residing in the 50 United States or DC (the "Promotion Area") who are 16 years old and older as of the Promotion start date. Employees of Sponsor, 6CONNEX, prize providers (if any), and each of their parents, affiliates, and subsidiaries, and of all of the vendors, promotion contractors, public relations companies, and other entities that participated in the creation, operation or fulfillment of this Promotion (collectively, "Promotion Entities"), and each of their immediate family members (spouse, parents, grandparents, siblings, children, grandchildren and in-laws) and household members (whether or not related), are not eligible to participate. Void where prohibited and outside Promotion Area. A potential winner may be requested to provide the Sponsor with proof that the potential winner is the authorized account holder of the email address associated with the winning entry and that all eligibility requirements are met.
- 2. How to enter:** To enter the Promotion, accurately complete the registration form for Tribune Publishing's free Virtual College Fair. To access the registration form, visit tribpubcollegefair.com (the "Website") and click on the link for the registration form. Your contact information must be accurate, and you must have a valid email account in order for your entry to be eligible. Incomplete entries will be disqualified, and Promotion Entities not responsible for entries that are lost, late, deleted, garbled, mis-delivered, or misdirected as a result of technical, Internet or other online difficulties. Received entries will not be returned or acknowledged. Entry information will be treated in accordance with the privacy policy on the registration website, which is located at <https://www.6connex.com/privacy-policy/> and which may be updated from time to time. Proof of sending is not proof of receipt by Sponsor. Sponsor will not accept screen shots as proof of entry. **Limit one entry per person and per email address; multiple entries from the same person or email address will be disqualified if discovered by Sponsor.** Any attempt by any entrant to obtain more than the stated number of entries using multiple/different email addresses, identities, registrations and logins, or any other methods will void such entries if discovered by Sponsor, and that entrant may be disqualified.
- 3. Winner Selection; Odds of Winning; Notification:** On or about March 30, 2021, Sponsor will select the potential winners by random drawing from all eligible entries. Odds of winning depend on the number of eligible entries. All activity arising out of and relating to the Promotion, including any reference to an entrant's status as a "winner," is subject to verification and/or auditing for compliance with the Official Rules, and entrants agree to cooperate with Sponsor concerning such verification and/or auditing. Sponsor will make all final decisions in any and all issues related to this Promotion.

Sponsor will attempt to notify potential winners using the information provided in the entry form, and each potential winners must respond within 48 hours of initial notification attempt. Winners (and parent or legal guardian of winner who is a minor in his/her state of residence) may be required to sign and return an Affidavit of Eligibility, Liability Waiver and Publicity Release (TN residents need not agree to publicity release), and/or certain tax documents, and, if so, any required documentation must be signed and returned to Sponsor within 72 hours of the time Sponsor sends it to winner and prior to receipt of prize. If termination, modification, or suspension occurs, notification will be posted at the Website.
